The program is open to any Grange member in good standing that is nominated.* It teaches the basics of communications, such as press release writing, newsletter planning and creation, interacting with the media, live streaming, social media management, and more. It has also grown to include additional training for future Grange leaders, with a special focus on the intersections of programming, membership recruitment, retention and engagement and communications. FELLOWS MUST ARRIVE AT THE HOTEL IN MINNEAPOLIS BY NO LATER THAN 5 p.m. on Friday, Nov. 1 and can leave anytime after the close of banquet on Saturday, Nov. 9 (10 p.m.) [it is recommended you plan to depart on Sunday, Nov. 10]. Applications are due May 20 to National Grange.

Deaf Activities Grant Deadline

Granges seeking up to \$500 from the Grange Foundation to support deaf activities or education and outreach must complete their application by May 1. Up to three grants may be awarded.

The application should be in document form and include name of State Grange, name and address of contact person, date of application, name of the project, description of the project, anticipated number of people involved, anticipated impact on the Grange (State and/or Local), anticipated impact on the Community or State, other anticipated results of the project.

Grants may be awarded for any project that enhances deaf education. Preference will be given to high-quality activities that involve significant numbers of individuals. Creativity and uniqueness of the projects will also be factored into the selection process. Any State Grange is eligible to apply for a grant to assist with a worthwhile project that may be planned within the state.

Notable findings in Snapshot of Rural Health in Colorado

- 51% of all rural counties do not have an active, licensed addiction counselor (27 of 47 counties)
- 9 of the 10 Colorado counties with the highest opioid overdose death rates are rural
- Median household income is 29% lower in rural areas of the state compared to urban areas (about a \$14k difference)
- Rural Colorado has high rates of public insurance (a 32% difference)
- Rural Colorado has a 38% higher teen pregnancy rate than urban parts of the state
