Betsy Huber Will Be Our Guest From National For State Session

Betsy E. Huber was born and raised on a dairy farm in Chester County, Pennsylvania. She has been a Grange member since the age of 5, was active in the Junior Grange, and held many offices in the Community and Pomona Granges, including President.

From 2002-2010, Betsy served as President (referred to in the Grange as Master) of the Pennsylvania State Grange, the first woman to hold that position. Previously she served six years as Vice President (known as Overseer) and held many other positions on the state, county, and local levels of the Grange. Following her term as State President, she returned to the State Grange as Government Relations Director for three years until she was elected President of the National Grange in November 2015 — also the first female to hold that position. She also serves as Executive Secretary of the Pennsylvania Young Farmers Association and as a Trustee of The Pennsylvania State University from 2005 to present.

From 1992 to 2002, Betsy was the Legislative Assistant to State Representative Arthur Hershey in his district office. Prior to that, she was employed by Lincoln Univer-

sity for three years and by the National Grange for seven years as secretary to the Women's Activities Department.

She served 24 years as a Supervisor of Upper Oxford Township, Chester County, and served as Treasurer of the Chester County Association of Township Officials and on several committees for the State Association. Other board memberships include PA FarmLink, PA Department of Environmental Protection Ag Advisory Committee, the PA Alliance for Livestock Care and Well-Being, and the PA State Council of Farm Organizations where she served as President for two years. She represented the Pennsylvania State Grange on the University of Pennsylvania, Veterinary School Board of Overseers from 2002 to 2015.

In November 2006 she was elected to the National Grange Board of Directors and in November 2007 she was elected Chair of the Board, serving until 2014.

For 39 years, she was married to Henry T. Huber, who passed away in 2006. They are the parents of three children and grandparents of eight, with two great-grandsons.

Great Plains Regional Conference Recap

Harry and I attended the Great Plains Regional Conference in Lawrence, Kansas. There were representatives from Nebraska, Kansas, Oklahoma, Texas and Colorado. The National Youth Director Charlene Espenshade and the National Junior Director Samantha Wilkins were present. National Lecturer Chris Hamp made an appearance via Skype. Friday evening we gathered for snacks and worked on three community service projects. Some made dog toys out of T-shirts, others tied fleece blankets and the rest decorated socks with puff paints for the elderly. Saturday morning the Youth left to participate in a Challenge course while the Juniors learned some sign language, made scrapbook pages and learned about the Awareness Project on Honey Bees.

There are several YouTube videos about bees on the Internet and the "Magic School Bus" has a special show on honey bees. So if your Grange needs a program you might consider checking out some of the YouTube possibilities.

There is an opportunity for all Grangers to become certified in Code Book reading and Roger Bostwick, Kansas State Master and Assembly of Demeter Priest Archon, instructed the group in reading the Grange Code Books. We learned that *the Grange is not a secret organization, but an organization with secrets*. If the Grange were a secret organization only members would know about it and we all know that many people who are not members know about the organization.

Via Skype Chris Hamp shared information about the National Grange Photography Contest, Program in a Box Contest and the Quilt Block Contest, as well as the plans for the Quilt Exhibition at National Session. They are looking for vendors to participate

and the cost for Grange vendors for the three-day expo is \$100. Commercial vendors space is also available. Donations from the Western Region states are providing the prizes for the contests she talked about. They are hoping to draw a big crowd from the Spokane, Wash., area for the event. The Tours at National for Youth and the general population will be the same this year.

The Program in a Box is to be submitted online if at all possible and it can cover a wide variety of topics. Maybe a member of your Grange will want to develop a program on maintaining a vehicle properly or how to use a fire extinguisher or on their occupation. The possibilities are limitless, but the program needs to be promoted in order for it to continue.

The Honor Program honoring different occupations (Policemen, First Responders, Nurses, Teachers, etc.) certificates can be obtained from National headquarters and each certifying

State Session Speaker

Doug Wiley of Larga Vista Ranch in Boone, will be our special guest speaker at this year's State Session. He is particularly knowledgeable about the challenges facing small, diverse, multi-generational family farms. He is a third generation farmer. The Larga Vista Ranch is nestled on the bluffs overlooking the Huerfano River near its confluence with the Arkansas; their family has farmed and cared for the land for more than 80 years. Great-grandmother Malone named this farm for the views of the beautiful mountain ranges to the west and the vast prairies to the east.

Over the years, they have always understood the importance of good stewardship of the land and water resources we have been entrusted with in this community. Our respect and gratitude for the vision of our ancestors continually anchors our hopes and dreams for the future while guiding our decisions to ensure the sustainability of this community for generations that follow.

During the past 20 years, they have eliminated the need for pesticides on the farm through the use of crop rotation, intensively managed irrigated pasture development, and sound animal nutrition practices. This has allowed them to move into the produc-

tion and marketing of high-quality meats and vegetables. Intensively managed mixed-species pastures are the foundation of our soil-building rotation. Livestock are rotated through lush pastures during the growing season and fed stored forages during the short winter period.



Soil fertility is maintained and improved by the animals themselves and through the use of compost, soil minerals, and supplemental micronutrients. All of these factors combine to create a viable soil mineral cycle, which provides the basis for healthy plant and animal nutrition, producing meats and vegetables of unsurpassed flavor and quality without the use of pesticides, antibiotics, hormones, and genetically modified organisms (GMOs).

They are becoming more concerned with the direction the food production and distribution system has taken over the past 30 to 40 years. The main goal seems to be to deliver cheap, fast food with little regard for nutritional quality or freshness. As they have learned the importance of fresh, nutrient-dense grass for the health of our livestock (and ultimately ourselves), they have also begun to realize the need to develop markets for locally grown food.

It is a good place to share ideas, and get new information. State and National Convention are the places where the policy for the State and National Grange is set through the resolutions that are sent in by Subordinate and Pomona Granges. The committees meet and discuss the pros and cons of the resolution. Most of the time those committees make a recommendation. The resolutions that receive a favorable recommendation are then presented to the delegate body and more discussion takes place with a formal vote, which is where we get our policy and the things we try to support over the next year. If there is Grange policy that you disagree with this is your opportunity to present information to try to change that policy.

State Session is the place where we can recognize the achievements of our local subordinate Granges through awards — Membership, Community Service, Lecturers and Achievement to name a few. The Mandy Project presents certificates to the Granges who have made donations this past year. Individuals receive awards for the items they send in for exhibit and judging, some of which are selected to be sent to National to represent our state.

This year is an election year at State Session and the delegates will be electing state officers for the next two years.

Granted, attending State Session is costly and time consuming, but we hope that your local subordinate Grange will help your delegates financially. State accomplishes a lot in the two and one-half days we meet. If we had more people attending the state convention it would be easier to book a block of rooms at a hotel/motel that could possibly give us a reduced rate, but that means that people need to choose to utilize that block of rooms and meet the deadlines. We have chosen to utilize facilities that are not too costly for the State Grange that meet our needs. If you know of a location that has a large meeting room, a kitchen and dining area, and an exhibit area that can house the numerous exhibits we have, that is a reasonable price, please share that information with us. Motel/hotels are expensive. Most of our Granges with adequate space have stairs and no elevator which puts them out of the picture for those with mobility issues.

If you haven't attended State Session before I encourage you to at least give it some serious consideration and become a part of the process of establishing policy, celebrating achievements, sharing ideas and learning more about others to improve your own local Grange. The State Grange officers give the Sixth Degree on Thursday evening; if you are not a Sixth Degree member this is your once a year opportunity to receive the degree. Join us for the Friday night at the Gala or at Saturday night's Celebration Banquet to celebrate your achievements and recognize an outstanding Granger.

We're very excited to have the National Master Betsy Huber joining us for Thursday and Friday this year. I hope to see many of you at State Session, I look forward to seeing old friends and new friends.

years ago the CSG approved a resolution supporting use of LFTB in ground beef products created by careful separation of protein from otherwise waste trimmings and scraps from beef carcasses. The product was produced by Beef Products Inc. and reported quite negatively by ABC News where the pink slime term was used. BPI then sued claiming ABC misled viewers about the quality of the product resulting in a loss of customers. ABC, owned by Disney, settled for \$177 million in an "amicable" outcome.

The Status Of Honey Bees — What's The Buzz?

Colorado Department of Agriculture Shares The Latest Survey Data On The Health Of Managed Honey Bees In Colorado

Bee pollinators play a crucial role in natural and agricultural ecosystems and contribute over \$200 billion in revenue from vegetable, fruit and nut production in the United States. To gain a better understanding of current honey bee health in Colorado, the Colorado Department of Agriculture has taken part in the National Honey Bee Health Survey for the last three years.

"Scientific surveys and research on honey bee health bear out that the past decade has been challenging for beekeeping with a decline in managed hives in the US," said Laura Pottorff, CDA Division of Plant Industry's Apiculture Program Manager. "Honey bees are a crucial part of our environment and the national survey provides a valuable insight into the state of managed honey bees in Colorado."

The Survey is an initiative sponsored by United States Department of Agriculture, Animal Plant Health Inspection Service (USDA-APHIS) and the Bee Informed Partnership. Honey bee researchers agree that there are many factors responsible for the challenges facing the valuable pollinator:

- infectious pests and diseases of managed honey bee populations that are not being controlled properly
- loss of habitat and habitat diversity due to increased urbanization
- improper use of pesticides toxic to pollinators
- lack of genetic diversity in managed bee populations

A total of 67 apiaries (27% hobby and 73% commercial) were sampled over three years for the Varroa mite, several honey bee viruses that Varroa spreads, and a fungal disease called Nosema. Varroa mites are parasitic animals that feed on the hemolymph (blood) of bees. Not only do Varroa mites cause injury to a honey bee by itself, they are also responsible for spreading several honey bee virus diseases. If left untreated, Varroa mites can kill a colony in two or three years and are thought to be the single most significant reason for high colony loss numbers during the winter.

"Nationally, surveys have determined that high Varroa mite numbers are particularly troubling for backyard beekeepers. Backyard or hobby beekeepers do not have appropriate Varroa controls in place," said Pottorff.

Beekeepers can learn more about integrated hive management including strategies for identifying and mitigating pests and diseases affecting Colorado's honey bees through

this booklet.

"CDA is committed to participating in the National Honeybee Health Survey, to further our understanding and strengthen the data so that we can make meaningful decisions toward protecting the future of pollinators in the State," continued Pottorff.
